REVIEW AND DISCUSSION REGARDING FINAL DRAFT OF STRATEGIC PLAN AND GOALS

Mr. Cross will have the authority to talk to businesses and the City of Peru to move forward with the implementation of outdoor facilities. He would like to check into the possibility of joining an energy consortium for some utilities. The Board also discussed how the district can assure that necessary upgrades to technology can always be purchased in the future. After some discussion, the Board agreed with the new mission statement of "Preparing our students to learn, grow and reach their greatest potential", as well as the "Teaching for 2020" beliefs, goals and strategies.
