IASB Joint Conference Updates

The Board of Education shared their thoughts and experiences regarding the 2023 Joint Annual Conference. Collectively, the Board agreed that there was a variety of sessions with three great keynote speakers. Member Kampwerth stated that there were over 9,000 people in attendance for the 90th conference.

Administrative Reports:

Northview School

• Parent Teacher Conferences held a 93% attendance rate by parents.

- Northview Winter Concert sessions are scheduled for December 19th and December 20th.
- Santa is coming to visit Northview on December 21st.
- Mid-term Progress Reports will be going out the Friday when we return from Winter Break.

Parkside School

Mr. Ziegler reported:

- Student attendance is at 95.3% daily attendance. Parkside will continue to make parental contacts with excessive absences, as well as celebrate our positive attendance with monthly incentives.
- Parkside has joined the SEL HUB and is creating an action plan, with the assistance of the Regional Office of Education. The plan explores the needs of our students and staff, as determined by a committee working to provide the best support in our school community.

Superintendent's Report

Mr. Craven reported:

- On Friday, December 1st Mr. Craven attended the Prairie State Insurance Cooperative (PSIC) full membership mid-year meeting. A few takeaways from the meeting are as follows: the co-op experienced a positive year regarding loss control, especially in the area of workers' compensation, cyber threats directed at school continue to be a focus and use of the company nurse and timing.
- The Peru Education Foundation meeting was held on December 6th. The total of approved grants was \$3,946.00. Trivia Night will be held on March 6th, 2024 at Senica's Oak Ridge in LaSalle.
- On December 19th, the Building & Grounds Committee met to review with District Architect, Jacob Been the most current Northview Addition plan and consider other possible options.
- The Strategic Planning Retreat will be held on January 13, 2024 at Senica's Oak Ridge, to review and update the current district goals and strategies.
- The proposed tax levy was presented and discussed at the November 14, 2023 Regular Board Meeting. The Truth in Taxation Notice was legally published on Monday, December 11, 2023, and a Public Levy Hearing was held on December 20, 2023. If there are no further questions, the Levy is ready to be adopted as presented.
- The 2024-2025 School District Calendar was presented which reflects a start date of August 15, 2024, and an end date of May 22, 2025.
- The recommendation for 8th Grade Graduation is to be held on Tuesday, May 21, 2024, at 7:00 p.m. in the Parkside Middle School Gymnasium.
- Review and recommendation to approve the Issue 113 October PRESS updated policies was presented. For policy 7:160, the recommendation is not to add the suggested PRESS language, rather leave the policy as it is currently written.
- Johannes Bus Service, Inc., has agreed to a two-year extension for our contract with a proposal of an 8% increase in year 1 and a 7% increase in year 2.
- Thompson Electronics Company performs our annual fire alarm device inspections for both buildings. They are proposing a 3-year contract of \$1,500.00 annually. Our current contract with them is \$1,485.00.
