#### **CALL TO ORDER**

#### PUBLIC COMMENT, CORRESPONDENCE, AND ANNOUNCEMENTS

Walt Zukowski attended the meeting and provided an overview of the Student Online Personal Protection Act (SOPPA) law and steps that school districts need to take to be in compliance. Walt also discussed the Tort Immunity Act as it relates to school districts and IDPH reopening guidance.

#### REPORTS, UPDATES, AND INFORMATIONAL ITEMS

Superintendent J. Craven provided a brief overview of the recently released CDC reopening guidance for schools. He shared that they are stressing Masks, Distancing, and Testing. He also reported that schools can expect an updated FAQ from IDPH and ISBE. The Reintegration Committee is scheduled to meet on July 29th but he is going to try to move that meeting up since new guidance is out.

J. Craven provided an overview of the SHIELD Illinois COVID screening program and reported that it will allow districts to regularly screen unvaccinated students and staff but also eliminate or greatly reduce quarantine time for those who may come in contact with a COVID positive individual. He shared that the SHIELD program prefers 50% or more of the unvaccinated students to participate in this program.
