### **IASB JOINT ANNUAL CONFERENCE UPDATE**

The Board engaged in discussion regarding their participation in the Joint Annual Conference last month, including the sessions attended. It was noted that the conference offered a significant amount of valuable information and had the largest attendance to date.

### **REPORTS, UPDATES, AND INFORMATIONAL ITEMS**

#### **ADMINISTRATIVE REPORTS**

##### **Mrs. McDonald Reported:**

Parent-teacher conferences were very well attended, with a 94.5% parent participation rate. The second-grade team successfully implemented standards-based report cards. Winter concerts were also well attended. Ms. Lindig was commended for her outstanding work.

##### **Mr. Ziegler Reported:**

Academic and at-risk reports continue to be reviewed consistently. Students have been enrolled in Project Success when recommended. Staff are encouraging students to remain motivated and finish strong before winter break. Attendance remains a primary focus, with letters sent to families regarding multiple student absences, while also recognizing students for good attendance. Parent-teacher conferences reflected a 71% parent participation rate. PLC teams are preparing for winter benchmark testing, and the Career Exploration Committee will meet again on January 5, with their template nearly finalized.

### **SUPERINTENDENT'S REPORT**

##### **Mr. Linnig Reported:**

Mr. Linnig recommended that the 8th grade graduation be held on May 21, 2026, at 6:00 p.m. in the Parkside Gymnasium. The district continues to work on restructuring its MTSS framework to ensure a district-wide approach, with the goal of implementation effective July 1 to address academic needs. During the following fiscal year, the district will work to address behavioral and social-emotional needs. Transportation costs continue to be a concern.

Meetings have been held with the administrative team to discuss options for managing special education transportation, including the use of district vehicles and staff. A meeting with Mrs. Baker and Johannes is being scheduled to discuss potential route changes to help reduce costs on regular routes. The second reading of the updated PRESS Issue 120 policies, Sections 2-5, is being recommended for adoption, with no substantial changes to these policies.

### **STRATEGIC PLAN UPDATE**

The district hired an EL Coordinator for the 2026-27 school year. Mr. Ziegler and Mrs. Meyer met with LP regarding the development of the Career Exploration program. The \$50,000 matching grant was formally approved on December 5. The tax levy requires a Truth in Taxation hearing due to a 5% increase in EAV; if estimates are accurate, the tax rate based on the requested levy will remain nearly the same as 2024. Mr. Linnig is tentatively scheduled to host the IVAC Education Day at Parkside on January 26.

### **FIRST READING OF PRESS ISSUE 120 UPDATED POLICIES SECTIONS 6-8**

Due to the large number of policies under review, PRESS Issue 120 – Updated Policies Sections 6-8 was presented for the first reading with final adoption in January.
