CALL TO ORDER

The meeting of the month of November of the Board of Education of Peru Elementary School District 124, LaSalle County, Illinois, was called to order in the Choral Room at Parkside Middle School by Board President Rob Ankiewicz, on Tuesday, November 18, 2025, at 6:00 p.m.

REPORTS, UPDATES, AND INFORMATIONAL ITEMS ADMINISTRATIVE REPORTS
Mrs. McDonald Reported:

- Project Success for grades 3–4 began on October 21.
- A special thank-you to the Rotary Club for delivering dictionaries to all 3rd-grade students. We appreciate this support each year and always look forward to their visit.
- A BPAC meeting was held on November 3; the next meeting is scheduled for May.
- The Northview Veterans Day Program was once again very well attended and well received. Thank you to Ms. Lindig, Northview's music teacher, for preparing the students and leading another wonderful performance.

Mr. Ziegler Reported:

- Parkside continues to see improved attendance, and this will remain a focus as we move into parent-teacher conferences.
- The Career Exploration Committee has met three times so far this school year and has developed a preliminary plan for grade-level objectives as we design and refine our PACE model.
- Our School Report Card designation has been released, and Parkside earned a Commendable status.
- The Veterans Day Program was once again a tremendous success and very well received by students, staff, and community members.

SUPERINTENDENT'S REPORT

Mr. Linnig Reported:

- Mr. Linnig complimented the Veterans Day programs at Northview and Parkside, noting excellent student performances, strong community attendance, and numerous compliments. Staff and students were commended for their efforts.
- American Education Week is November 17.
- Illinois School Board Appreciation Day is November 15. Mr. Linnig expressed gratitude to the Board for their time, dedication, and commitment to student and school success.
- Risk Management Plan: Included in the packet for annual approval prior to levy adoption. No changes are recommended. The plan justifies eligible expenses paid from the Tort/Liability Fund.
- Discipline Improvement Plan: Required after the 2022–23 school year due to minority suspension rates being in the top 20% statewide. The District fell below the threshold in 2023–24 and 2024–25. If below the threshold for a third consecutive year, submission will no longer be required. The committee met November 10, and the action plan requires Board approval.
- Johannes Contract Extension: Proposal for a 1-year extension at 4.25% (negotiated down from 5%). Board approval recommended.

2024-2025 SCHOOL REPORT CARD UPDATE

Mr. Linnig provided the Board of Education with a link to the Illinois School Report Card for their review of the district data. Both Northview and Parkside received a Commendable designation.

PRESENTATION OF THE TENTATIVE 2025 TAX LEVY

Mr. Linnig provided a review the EAV, estimated extension, exemptions, abatement savings, and the tentative levy. Current estimates show the tax rate holding steady, with a slight change from \$3.19735 to \$3.19721. With an estimated 6.51% increase in EAV and a levy request over 5%, we must post notice and hold a truth-in-taxation hearing at the December meeting.

The FY26 Budget summary was included to provide required fund balance information. The abatement resolution is also included; this year's sales tax agreement with the City of Peru allows the District to abate \$1,556,899, reducing the tax rate by about \$0.60.

STRATEGIC PLAN UPDATE

- BPAC & Staffing: Mrs. Baker led the Northview Bilingual Parent Advisory Committee on Nov. 5; EL Coordinator hiring expected Nov. 18.
- Career Exploration & MTSS: Committees are developing grade-level objectives, integrating career exploration, and standardizing district-wide MTSS supports (academic focus 2025–26, social-emotional 2026–27).
- Facilities & Grants: Awaiting ISBE/IMEA grants to upgrade Parkside facilities and security systems; Northview entrance repairs completed.
- Finance & Tax Levy: 2025 Tentative Tax Levy to be presented; rate expected to remain nearly unchanged. FY26 budget includes ongoing cost-saving measures.
- Surveys & Reporting: Fall culture and climate surveys shared with leadership; Annual Statement of Affairs reporting streamlined for FY25, reducing costs and administrative time.

FIRST READING OF PRESS ISSUE 120 UPDATED POLICIES

Due to the large number of policies under review, PRESS Issue 120 – Updated Policies Sections 2–5 was provided for first reading and review and will be recommended for adoption at the December meeting. The remaining Sections 6–8 will be presented for first reading in December with final adoption in January.

2025 JOINT ANNUAL CONFERENCE REVIEW & PLANNING

The conference itinerary and related materials were provided to the Board of Education for review.
