CALL TO ORDER

ADMINISTRATIVE REPORTS

Mrs. McDonald's reported:

- Currently there are 86 students registered for Bright Futures Preschool for next year. Of those 86, 55 are returning 2nd year PreK students and 31 are brand new.
- The Summer Book Bag Committee will be sending 116 summer book bags that will be going home with students this summer.
- The Northview SIP Committee continues to work hard at analyzing test score data in Math and ELA.

Mr. Ziegler Reported:

- Attendance continues to be promoted with monthly recognition and incentives. In April, Parkside had 316 students with 1.5 or fewer absences.
- Professional development has been focusing on scheduling for the 2025-26 school year. In addition, Math PLC has designed grade level interventions for the state of the school year.
- Scholastic Bowl brought home a 2nd place trophy at the Starved Rock Conference Tournament.

PRESENTATION OF THE 2024-25 AMENDED BUDGET

Mr. Craven provided the Board with a 2024-25 budget update. Final adoption of the 2024-25 amended budget will occur during a budget hearing prior to the regular June meeting.

PROPOSED TRANSPORTATION CHANGES FOR 2025-26

Mrs. Baker and Mr. Craven presented the Board with proposed transportation changes submitted by Johannes Bus Service. In the end, the Board decided to postpone the discussion.

FIRST READING OF PRESS ISSUE 118 APRIL 2025 POLICY UPDATES

Mr. Craven presented the policies that are up for review in PRESS Issue 118.

STRATEGIC PLAN UPDATE

Mr. Craven provided strategic plan updates which include the following:

- BPAC meeting was held on May 8th with a great turnout.
- Northview hired an EL paraprofessional.
- LP Career Center Visit for Parkside students.
- A meeting with the City of Peru is pending for discussion and review of the financing options for creating additional classroom space at Northview.
- Technology purchases for the 2025-26 school year were approved at the April meeting.

SUPERINTENDENT'S REPORT

Mr. Craven Reported:

- As a reminder, 8th grade graduation is on May 28th at 7:00 p.m.
- This year's final budget will reflect some expenditure changes and line item adjustments. We will amend both the Education Fund and Transporation Fund.
- The 2025-26 PSIC renewal reflects an on overall 13% increase.
- Mr. Craven recommends that the Board approve a three-year contract with Curriculum Associates for the district's iReady Math program. This program was adopted in 2020 and the district has seen considerable improvement in Math scores since its adoption. The total amount will be \$121,511.50 but paid in annual installments as noted below:

First invoice of \$60,775.75 due this year (July 2025 budget)
Second invoice of \$30,387.87 for the 2026-27 school year (July 2026 budget)
Third invoice of \$30,387.87 for the 2027-28 school year (July 2027 budget)
